BRUNNER, to be executed in favor of The City of San Diego, the form of which deed is on file in the office of the City Clerk as Document No. RR- 272934, granting to said City a 2,888-square-foot parcel of improved land, being a portion of Villa Lot 5, Tract 1361, Resubdivision of Lot 12 of Normal Heights, Map 1361, as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the transfer of an amount not to exceed \$150,000 from C.I.P. 29-608.0, Cherokee Park, Mid-City Park Development Fund 39094, to C.I.P. 29-566.0, Mid-City Park Site - Acquisition, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from C.I.P. 29-566.0, Mid-City Park Site - Acquisition, to cover acquisition, relocation, appraisal and miscellaneous costs in connection with the acquisition of the above described real property, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk, upon execution of said grant deed, shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.

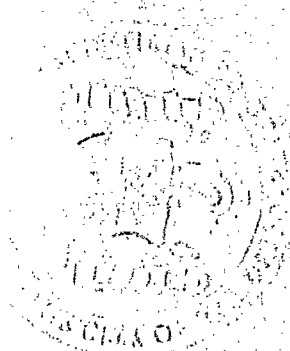
