BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$5,800 from CIP 11-242, Gas Tax Fund 302191, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.

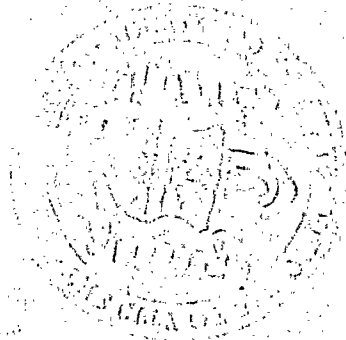
