No. 37-187.0, Underground Petroleum Abatement Project, is hereby authorized, solely and exclusively for the purpose of providing funds for construction and related costs for the above project and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

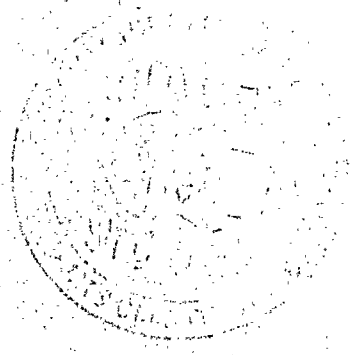
