RESOLUTION NUMBER R- 272961

ADOPTED ON FEB 27 1989

WHEREAS, jail overcrowding in San Diego County continues to inhibit the ability of the Police Department to book misdemeanor law violators, and,

WHEREAS, the shortage of jail space has resulted in limiting misdemeanor bookings to the following violations: Health and Safety Code section 11550 (under the influence of a controlled substance); Vehicle Code section 23152 (a) (driving under the influence); Penal Code Code section 647 (f) (drunk in public/inebriate reception refusals); Penal Code section 273.5 (domestic violence); and Penal Code section 647 (b) (prostitution); and

WHEREAS, misdemeanor violations by males such as carrying concealed, loaded firearms; batteries; assaults; noise disturbances; attempting to evade a peace officer; and obstructing a peace officer in the performance of duty are handled thorough citations or notify warrant requests; and

WHEREAS, in June, 1988 the voters approved Proposition A, a one and one half (1 1/2) cent sales tax measure which is seen as the prime funding source for jail construction over the next ten (10) years with anticipated revenues of one and six tenths billion (\$1.6,000,000,000) dollars and first year revenues of approximately one hundred million (\$100,000,000) dollars with an estimated nine (9) percent increase each year; and

WHEREAS, The Sheriff's facility budget and development timetable, projected population growth, pending lawsuits, court orders on jail conditions and overcrowding, current conditions will improve little in the next three (3) years; and

WHEREAS, The City of San Diego needs a temporary two hundred (200) bed facility for San Diego Police Department prisoners not presently eligible for placement in the county jail due to restricted booking policies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to request funding from the San Diego Regional Justice Facilities Financing Agency for the construction and operation of a temporary Misdemeanor Prearrest Detention Facility utilizing Proposition A (one and one half (1 1/2) cent sales tax earmarked for jail construction) funds; and

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Request for Proposal for the design, construction and operation of a Misdemeanor Prearrest Detention Facility for use by the San Diego Police Department.
