
ADOPTED ON FEB 27 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to initiate negotiations for a right of entry permit to MISSION VALLEY ASSOCIATES to grade a portion of City-owned Site 19, Area A, and remove excess excavated material to other areas of their adjacent Mission City development.

BE IT FURTHER RESOLVED, that upon completion of successful negotiations and subject to the preparation and review of an appropriate environmental document, it is acknowledged that the City Manager may execute the right of entry permit pursuant to the authority vested in the City Manager under the provisions of section 22.0901 of the City's Municipal Code.

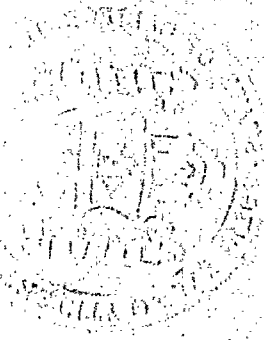
