
WHEREAS, the Sixth Amendment to the Redevelopment Plan for the Columbia Redevelopment Project constitutes an amendment to the Local Coastal Program; and

WHEREAS, the City Council has reviewed the proposed amendment, hearing all public testimony; NOW, THEREFORE,

BE IT RESOLVED, by the Council for The City of San Diego, that it hereby approves and adopts the Sixth Amendment to the Redevelopment Plan for the Columbia Redevelopment Project as an amendment to the Local Coastal Program and an amendment to the "Progress Guide and General Plan" for The City of San Diego which will be implemented after certification by the California Coastal Commission and directs and authorizes the transmittal of the Sixth Amendment to the Redevelopment Plan for the Columbia Redevelopment Project to the California Coastal Commission for final certification.

BE IT FURTHER RESOLVED, by the City Council, that pursuant to Section 100.5, as added to the Columbia Redevelopment Plan by the Sixth Amendment, the elements of the Sixth Amendment which apply to the Coastal Zone shall become operative from and after the date (if any) of their certification as submitted by the California Coastal Commission.

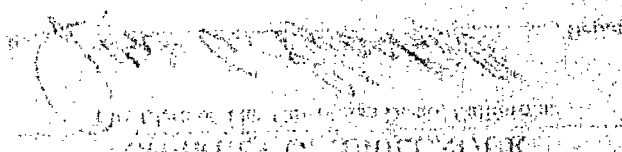
