WHEREAS, in 1988, the Community Mediation Program provided dispute resolution services to more than 1800 people with a resolution rate of 91%; and

WHEREAS, over 100 volunteers provided approximately 5,500 hours of service to the Community Mediation Program in 1988 through participation in training, mediation services, outreach, and Advisory Board activities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby proclaim the month of March 1989 to be "MEDIATION MONTH" in full support of the Community Mediation Program and its noble goals dedicated to serving the citizens of San Diego.
