BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the second low bid of \$478,368 by COMMERCIAL BUILDERS AND CONTRACTORS, INC., a corporation, meeting specifications for CONSTRUCTION OF PENN ATHLETIC AREA - DEVELOPMENT, PHASE III, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 118744.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$75,000 from PSD Fund No. 11700 to CIP No. 23-386.1 PENN ATHLETIC AREA - DEVELOPMENT, PHASE III.

3. That the expenditure, not to exceed \$75,000 from CIP No. 23-386.1 PENN ATHLETIC AREA - DEVELOPMENT, PHASE III to supplement funds previously authorized by Resolution No. 272359, adopted on November 21, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
