BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the low bid of \$136,736 by L.R. HUBBARD CONSTRUCTION CO. INC., a corporation, meeting specifications for CONSTRUCTION OF MIRA MESA COMMUNITY PARK PICNIC SHELTER; CONSTRUCTION OF STANDLEY COMMUNITY PARK PICNIC SHELTER; SOUTH BAY COMMUNITY PARK IMPROVEMENTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document Nos. 118926, 118930 and 118921.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer \$3,000 from PSD Fund No. 11220 to CIP No. 29-597 MIRA MESA COMMUNITY PARK PICNIC SHELTER and \$11,000 from PSD Fund No. 13000 to CIP No. 29-602 STANDLEY COMMUNITY PARK PICNIC SHELTER.
- 3. That the expenditure, not to exceed \$14,000 (\$3,000 from CIP No. 29-597 MIRA MESA COMMUNITY PARK PICNIC SHELTER and \$11,000 from CIP No. 29-602 STANDLEY COMMUNITY PARK PICNIC SHELTER) to supplement funds previously authorized by Resolution No. 272401, adopted on November 28, 1988, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
