APPROVING PARCEL MAP T.M. NO. 86-0356.

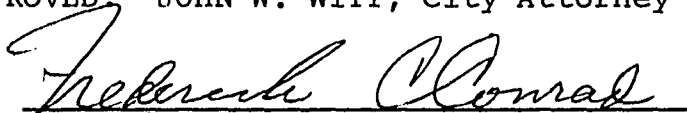
BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Jerry A. Helms, Registered Civil Engineer, entitled "PARCEL MAP T.M. NO. 86-0356 being a division of Lot 91, of Highdale Addition to Encanto Heights, according to map thereof No. 1176, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of said San Diego County, April 30, 1909," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Attix Street, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said parcel map, and that said portion of a street is accepted on behalf of the public as heretofore stated; all as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
