RESOLUTION OF FEASIBILITY FOR THE IMPROVEMENT OF PROJECT FIRST CLASS ALLEY & SEWER REPLACEMENT - CONTRACT NO. 4, UNDER THE PROVISIONS OF THE SAN DIEGO MUNICIPAL CODE AND THE IMPROVEMENT ACT OF 1911.

- 1. Each and all oral and written protests and objections, if any, made or filed in the matter are hereby overruled and denied.
- 2. The proposed improvement within the limits mentioned in Resolution of Intention No. R-272721 is hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed assessment, and that

the public convenience and necessity require the proposed improvement, and that the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 shall not apply.
