RESOLUTION NUMBER R- 273017

ADOPTED ON MAR 7 1989

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for FRONT STREET AND FIRST AVENUE - EXTENSION TO HARBOR DRIVE, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAR 7 1989, and bearing official Document No. W.O. 118812, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for FRONT STREET AND FIRST AVENUE - EXTENSION TO HARBOR DRIVE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$120,000 from CIP No. 52-422 BLACK MOUNTAIN ROAD BRIDGE to CIP No. 52-363 FRONT STREET AND FIRST AVENUE - EXTENSION TO HARBOR DRIVE.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller, upon receipt of \$673,300 from the Redevelopment Agent, is hereby authorized to allocate these funds for the hereinabove described purpose.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$1,898,645 from CIP No. 52-363 FRONT STREET AND FIRST AVENUE - EXTENSION TO HARBOR DRIVE is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute for and on behalf of the City of San Diego an agreement with the Metropolitan Transit Development Board in accordance with the form on file in the Office of the City Clerk as Document No. RR-273017 for track crossing improvements relative to Front Street and First Avenue - Extension to Harbor Drive and existing Eighth Avenue crossing.
