
RESOLUTION NUMBER R- 273019

BE IT RESOLVED, by the Council of The City of San Diego, that it authorizes the transfer of Two Hundred Fifty-Nine Thousand, Six Hundred Seventy-Two Dollars and Forty Cents (\$259,672.40) to the Redevelopment Agency, Fund 98200, Dept. 98200, Object Account 2001, Work Order 002001, Cost Account 4141, to cover the cost of hiring consultants to proceed with redevelopment activities in Mid-City from the following sources: Sixty-Six Thousand Two Hundred Forty-Seven Dollars and Forty Cents (\$66,247.40) from Fund 18502 (Program Income); One Hundred Thousand Dollars (\$100,000) from Fund 18523, Dept. 5636, Org. 3602; and Ninety-Three Thousand Four Hundred Twenty-Five Dollars (\$93,425) from Fund 18519, Dept. 5713, Org. 1301.
