WHEREAS, Mr. Williams participates in the transporting of senior citizens to doctor appointments, manning the telephone assurance line and many other activities in the senior program; and


WHEREAS, Mr. Williams is an outstanding volunteer and spends time lecturing and encouraging community involvement; and
