ADOPTED ON MAR 20 1989

BE IT RESOLVED, by the Council of The City of San Diego that the low bids of (a) COSBY OIL COMPANY, INC., (b) CHEVRON U.S.A., INC., (c) BARNICLE OIL CO. and (d) SAN DIEGO PETROLEUM CORPORATION meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing and delivering GASOLINE AND DIESEL FUEL, as may be required for a period of one (1) year beginning April 1, 1989 through March 31, 1990, per prices on file in the Purchasing Department, with an option to renew the contracts for an additional one (1) year period.

- (a) COSBY OIL COMPANY, INC. for Section I - Truck/Trailer Deliveries of Regular Unleaded Gasoline and Regular Leaded Gasoline; terms net 30 days, plus sales tax
- (b) CHEVRON U.S.A., INC. for Section II - Truck/Trailer Deliveries of No. 2 Diesel Fuel; terms net 30 days, plus sales tax.
- (c) BARNICLE OIL CO. for Section III - Tank/Wagon Deliveries of Regular Unleaded Gasoline, Regular Leaded Gasoline and Premium Unleaded Gasoline; and for Section V - No. 1 Diesel Fuel; terms net 30 days, plus sales tax.
- (d) SAN DIEGO PETROLEUM CORPORATION for Section IV - Tank/Wagon Deliveries of No. 2 Diesel Fuel; terms 1/2 $\frac{1}{2}$  10 days, plus sales tax.

BE IT FURTHER RESOLVED, that the Purchasing Agent is hereby authorized to purchase gasoline and diesel fuel on the open market if the regular contracted suppliers are unable to deliver fuel in case of fuel shortages of for other reasons.
