

BE IT FURTHER RESOLVED, the Irrevocable Letter of Credit No. 09-012A-88ISB, issued by Imperial Savings Association, in the amount of \$649,209.00 is hereby accepted as the surety for the required improvements in said subdivision, and substituted as Exhibit "C" to the aforesaid agreement and that Performance Bond

No. 939360S, issued by Developers Insurance Company, in the amount of \$649,209.00 is hereby released.
