Donna Klimas	Treasurer	\$236.39	Ms. Klimas is a Senior Cashier. She suggested using plastic bags and plastic seals to seal checks and cash. This is expected to save \$1,575.90 in hourly savings. This is a partial award pending a 12-month review.
Hadrian Liberatore, Jr.	Fire	\$ 90.00	Mr. Liberatore is a Captain. He suggested having the incident Commander at a second alarm fire be given a secondary tactical radio channel. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Albert D. Johnson	Purchasing	\$ 80.00	Mr. Johnson was a Senior Building Maintenance Supervisor at the time of this suggestion. He suggested delivering items going to the tank to any storeroom. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Kenneth McLaughlin	Fire	\$ 50.00	Mr. McLaughlin is a Fire Engineer. He suggested giving two portable radios to Brown Field Tower for communications with SDFD apparatus. Although savings are difficult to identify, this was considered to be a significant operational improvement.
