WHEREAS, The City of San Diego has a need for police initiated blood drawing services for law enforcement purposes; and

WHEREAS, because the City does not have licensed and qualified personnel on duty at the Police Department at all times for this purpose, the City issued a request for proposals to provide blood drawing services as needed; and

WHEREAS, on November 20, 1987, MAAS Diagnostic Laboratories ~~submitted the only responsive proposal to provide police~~ initiated blood drawing services to the City; and

WHEREAS, the City Manager executed, for and on behalf of said City, an agreement with MAAS Diagnostic Laboratories for provision on an as required basis of police initiated blood drawing services for law enforcement purposes from April 1, 1988, through March 31, 1989, with options for four (4) one (1) year extensions, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-271071; and

WHEREAS, MAAS Diagnostic Laboratories is being purchased by Smith Kline Bioscience Laboratory and has agreed as a condition of purchase to assume the contractual obligations of MAAS Diagnostic Laboratories to perform blood-draw services for the Police Department at no change in the service level or cost;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement consenting to the delegation from MAAS Diagnostic Laboratories to Smith Kline Bioscience Laboratory of its duties to provide on an as required basis police initiated blood drawing services for law enforcement purposes from April 1, 1988, through March 31, 1989, with options for four (4) one(1) year extensions, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document NO. RR-271071.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller are hereby authorized to expend funds on an as required basis.
