RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO, CALIFORNIA, APPROVING AND  
AUTHORIZING EXECUTION OF CERTAIN AGREEMENTS  
AND AMENDMENTS IN AN ASSESSMENT DISTRICT.

(Assessment District No. 4013 [Calle Cristobal])

WHEREAS, the City Council of The City of San Diego,  
California, is considering the formation of a special assessment  
district under the terms and provisions of the "Municipal  
Improvement Act of 1913," being Division 12 of the Streets and  
Highway Code of the State of California, for the construction  
and/or acquisition of certain public works of improvement in a  
special assessment district, said assessment district known and  
designated as Assessment District No. 4013 (Calle Cristobal)  
(hereinafter referred to as the "Assessment District"); and

WHEREAS, the Streets and Highways Code of the State of  
California, specifically the "Municipal Improvement Act of 1913,"  
expressly authorizes the acquisition of any improvements that are  
authorized to be constructed under said law, and the property  
owner, in order to proceed in a timely way with his development,  
desires to construct and/or cause the construction of certain  
works of improvement prior to the adoption of the Resolution of  
Intention; and

WHEREAS, at this time there has been submitted to this City  
Council for review and approval, certain amendments to consulting

agreements, and Acquisition/Financing Agreements setting forth certain terms and conditions, as well as estimated prices and quantities of work to be installed and financed pursuant to the said Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the above recitals are all true and correct.

Section 2. That the Acquisition/Financing Agreement submitted herewith, Document No. D2258-9, by and between the City and Newland, California is hereby approved, and the Acquisition/Financing Agreement submitted herewith, Document No. D2258-10, by and between the City and Douglas Allred Company, is hereby approved, and the City Manager be and he is hereby authorized to execute said Agreements on behalf of the City.

Section 3. That the Assessment District Reimbursement Agreements, Document No. D-2258-4, as previously approved by and between the City and Lusk/Smith Mira Mesa North, Genstar Development, Inc., and The Fieldstone Company, are hereby increased by \$29,310, \$375,063, and \$138,410 respectively.


Section 4. That the First Amendment to Agreement for Assessment Engineering Services submitted herewith, a copy of which is on file in the Office of the City Clerk as Document No. D2258-6, by and between the City and Willdan Associates, is hereby approved, and the City Manager be and he is hereby authorized to execute said Amendment on behalf of the City.

Section 5. That the Second Amendment to Agreement for Financial Consulting Services submitted herewith, Document No. D2258-5, by and between the City and Kadie Jensen, Johnson & Bodnar, is hereby approved, and the City Manger be and he is hereby authorized to execute said Amendment on behalf of the City.

Section 6. That the Second Amendment to Agreement for Engineering Services submitted herewith, Document No. D2258-7 by and between the City and VTN, Inc., is hereby approved, and the City Manager be and he is hereby authorized to execute said Amendment on behalf of the City.
