RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING AND PROVIDING FOR CONTRIBUTION TO PAY CERTAIN COSTS AND EXPENSES IN AN ASSESSMENT DISTRICT.

(Assessment District No. 4013 [Calle Cristobal])

WHEREAS, the City Council of The City of San Diego, California, has, by resolution, declared its intention to authorize the construction of certain works of improvement pursuant to the terms and provision of the "Municipal Improvement Act of 1913," being Division 12 of the Streets and Highways Code of the State of California, in a special assessment district known and designated as Assessment District No. 413 (Calle Cristobal) (hereinafter referred to as the "Assessment District"); and

WHEREAS, this City Council is desirous at this time of providing a contribution to pay a portion of the costs and expenses of the work and proceedings; and

WHEREAS, the City Council, pursuant to the provisions of Section 10205 of the Streets and Highways Code of the State of California, may so provide for a contribution to pay a portion of the costs and expenses at any time prior to the confirmation of the proceedings on said Assessment District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


Section 1. That the above recitals are all true and correct.

Section 2. That the City Council hereby approves and authorized the expenditure of \$1,700,000.00 from Fund No. 79006, Revenue Account No. 73460, Mira Mesa Facilities Benefit Assessment, as set forth as a contribution in the Engineer's "Report," as herein presented, related to the above-referenced Assessment District. Said contribution shall be used to pay for the items of work as set forth in said Engineer's "Report".

Section 3. That said contribution is authorized pursuant to Section 10205 of the "Municipal Improvement Act of 1913," being Division 12 of the Streets and Highways Code of the State of California.
