

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to accept a City standard form Grant Deed to be subsequently executed by Gary A. Earle and Daniel M. Whitaker of Whitaker Investment Corporation, conveying to the City Lots 1 thru 8, inclusive, Block 27 of Thomas' Resubdivision of Block 27, Horton's Addition, together with the south half of the alley as vacated by Council Resolution 82006 adopted October 20, 1945.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$1.25 million from C.I.P. 37-220, Civic Center Complex, to cover the cost of the above described acquisition is hereby authorized.

BE IT FURTHER RESOLVED, that the City Council hereby acknowledges its obligation to reimburse the City's Water Utility for said expenditure, plus simple interest at the rate of eight percent (8%), in the event the proposed Civic Center Complex,



which is now only in a conceptual state, does not in fact ultimately proceed to commencement of construction within ten (10) years following the date of this resolution, with such reimbursement to be made from any available City funds.
