WHEREAS, The City of San Diego employs a total of one hundred and seventy one (171) radio and telephone dispatchers in the Police, Fire and General Services Department, working at all hours of the day, throughout the year, serving the public; and

WHEREAS, a dispatcher is the public's first contact when requesting emergency medical aid, assistance in reporting fires, criminal acts, damaged City property, or information on a variety of other subjects; and

WHEREAS, the City's dispatchers received over two million (2,000,000) telephone calls during calendar year 1988, resulting in over eight hundred thousand (800,000) dispatches, and

WHEREAS, the unheralded actions of dispatchers have a significant impact upon the daily lives of San Diego citizens;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that April 10 through 16, 1989, be and it is hereby declared NATIONAL DISPATCHER WEEK.
