BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of OTTAWA TRUCK CORPORATION, meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of REFUSE PACKERS; two (2) each twenty-five (25) cubic yard rear loader (Rogue Model LERL cab and chassis with a Pak-Mor R325 refuse body) at a cost of \$86,912.00 each; and nine (9) each thirty-seven (37) cubic yard side loader (Rogue Model LESL-TA cab and chassis with a Maxon Legal SL-109-37 refuse body) at a cost of \$93,386.00 each, for a total combined cost of \$1,014,298.00; terms net 30 days, plus sales tax.
