BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by John D. Leppert, Registered Civil Engineer, entitled "PARCEL MAP T.M. NO. 87-0893, being a division of Lot 1 of Griffith Industrial Tract, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 6127, filed in the Office of the County Recorder of San Diego County, June 12, 1968," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Murray Canyon Road and Frazee Road, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council and that said Council has approved said subdivision map, and that said portions of streets are accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
