APPROVING PARCEL MAP W.O. NO. 880533.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "Parcel Map being a consolidation of Lots 15 through 21 inclusive, of Mission City Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 11676, filed in the Office of the County Recorder of San Diego County, December 12, 1986, together with Northside Drive as dedicated to public use, and together with Mission City Court and a portion of Northside Drive as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Northside Drive and said portion of street is hereby declared to be a portion of public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Parcel 2, marked "Reserved for Future Streets," as shown on the map, under the provisions of Government Code Section 66440.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities and slopes, as granted and shown on the map within the subdivision and subject to the conditions set forth thereof.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the building restricted easement over, upon or across all of Parcel 3, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of street is accepted on behalf of the public as heretofore stated; that said Council has rejected a portion of Parcel 2 marked "Reserved for Future Street"; together with the easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities and slopes, as well as the building restricted easement, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.



BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Mission City Court, a

as approved by Council Resolution No. R-271869, on September 19,  
1988, concurrently with the filing of the map.
