WHEREAS, The City of San Diego is the owner of an emergency access easement in Lot 14 of International Business Center Subdivision; and

WHEREAS, the City desires to negotiate the sale of said land to GADKO/OTAY MESA, LTD., a California limited partnership, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City is NINE HUNDRED DOLLARS (\$900), being the cost of processing the sale; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that quitclaim deed on file in the office of the City Clerk as Document No. RR-273119, be, and the same is hereby authorized to be sold by negotiation for the amount of NINE HUNDRED DOLLARS (\$900) to GADKO/OTAY MESA, LTD.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

4. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
