ADOPTED ON APR 3 1989

WHEREAS, Mrs. Gladys Hakel, a long-time resident of San Diego, died on December 9, 1987, leaving a portion of her estate to The City of San Diego; and

WHEREAS, the will of Gladys Hakel specified that the bequest to The City of San Diego be used for improvements and maintenance of the grounds of Balboa Park; and


WHEREAS, the initial disbursement from the estate of Gladys Hakel is \$71,500 and, from time to time over the next several years, additional funds will be disbursed totaling about \$5,000;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that a permanent trust fund be established with the bequest from Gladys Hakel by and within San Diego Community Foundation.

BE IT FURTHER RESOLVED, that the interest only, each year, from the permanent trust fund as established above be used by the San Diego Community Foundation solely and exclusively for Balboa Park.
