WHEREAS, The City of San Diego has entered into an agreement with the City of Santa Cruz to participate in a consortium to provide information on the impacts of proposed federal oil and gas leases off the southern, central, and northern California coastline; and

WHEREAS, said agreement is on file in the office of the City Clerk as Document No. RR-271570; and

WHEREAS, it is desired to amend said agreement by amending section 1 relating to contribution of funds so that provision is made for contribution of \$1,700 in fiscal year 1989; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that section 1 of the agreement between the City of Santa Cruz and The City of San Diego pertaining to the funding of the "Oil Information Program," a copy of which is on file in the office of the City Clerk, as Document No. RR-271570, be and the same is hereby amended to read, as follows:

1. CONTRIBUTION OF FUNDS. The City of San Diego agrees to contribute to the City of Santa Cruz, the sum of \$1,500 as its initial share of consortium costs to assist in the support of the Oil Information Program and thereafter, in fiscal year 1989, contribute the additional sum of \$1,700 for the purpose of supporting further informational efforts.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer within the General Fund 100 the sum of \$1,700 from the Unallocated Reserve (605) to the Allocated Reserve (901) for the purpose of funding said program in fiscal year 1989 and thereafter expend said funds for the specified purpose.
