BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$30,000 per year from Fund 10330 is hereby authorized solely and exclusively for providing maintenance of the elevators per Schedule IA, II and III for SAN DIEGO JACK MURPHY STADIUM ELEVATOR RENOVATION PROJECT AND FULL MAINTENANCE SERVICE.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$460,000 from Stadium Fund 10332, CIP No. 34-110 SAN DIEGO JACK MURPHY STADIUM ELEVATOR RENOVATION PROJECT is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to Fund 10330.
