WHEREAS, SAN DIEGO UNIFIED PORT DISTRICT has requested an exchange of water and drainage easements located westerly of the intersection of Harbor Drive and Fifth Avenue; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and


WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of SAN DIEGO UNIFIED PORT DISTRICT, which deed provides for the abandonment of certain water and drainage easements in exchange for certain new water and drainage easements located westerly of the intersection of Harbor Drive and Fifth Avenue, as more particularly described in the deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 273188, is hereby approved.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder, at no fee, for the benefit of the City, with no documentary tax due.
