
ADOPTED ON APR 10 1989

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a street easement deed of PGP SOUTH BAY, LTD., a California limited partnership, executed in favor of The City of San Diego, bearing date of December 30, 1988, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 273189, granting to said City an easement for public street purposes in a portion of Section 35, Township 18 South, Range 2 West, S.B.M., and in a portion of Section 2, Township 19 South, Range 2 West, S.B.M., as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SAN YSIDRO BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.

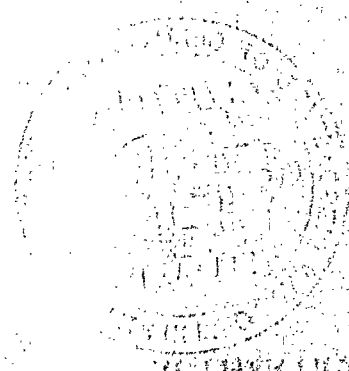
