BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$490,000 within the Water Revenue Fund, No. 41502, from the Water Systems Construction Program (No. 70592), CIP No. 73-248.0 Pomerado Pipeline No. 2, to the Water Engineering Construction Program, (No. 70893), CIP No. 73-275.0, Water Facilities Master Plan, thereby increasing the total project allocation of CIP No. 73-275.0 to the amount of \$1,490,000 for the purpose of providing funding for

consulting services in the amount of \$1,170,904; for initial San Diego Data Processing Corporation expenses in the amount of \$264,373; and for City administration and project related costs in the amount of \$54,723.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,170,904 from the Water Engineering Construction Program (No. 70893), CIP No. 73-275.0, Water Facilities Master Plan, is hereby authorized, solely and exclusively for the purpose of providing funds for the above projects.
