RESOLUTION NUMBER R- 273204

ADOPTED ON APR 10 1989

WHEREAS, Senate Bill 323, introduced by Assemblymember Torres, would prohibit building standards and other regulations adopted by the State Fire Marshal or by any other state or local agency from exempting, except as specified, any existing high-rise structure from containing approved automatic fire sprinkler systems; and

WHEREAS the installation of fire sprinklers in high-rise structures helps to reduce the loss of life and property which result from high-rise structure fires; and

WHEREAS, the Council of The City of San Diego on September 6, 1988 adopted Ordinance No. O-17172 (New Series) amending the San Diego Municipal Code to require that all high-rise structures within the City be retrofitted with fire sprinkler systems; and

WHEREAS, although it is the opinion of the City Council that Ordinance No. O-17172 (N.S.) is more effective in requiring the installation of fire suppression systems in high-rise structures, nevertheless statewide regulation of fire safety in high-rise structures is of greater importance; and

WHEREAS, on March 15, 1989, the Rules Committee of The City of San Diego reviewed Intergovernmental Relations Department Report No. 89-13, dated March 9, 1989, regarding SB 323 and recommended that the Council support SB 323 with amendments thereto, including but not limited to a clarification of the

criteria the San Diego Fire Department will use to exempt residential high-rise structures; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations contained in Intergovernmental Relations Report No. 89-13 dated March 9, 1989, to support SB 323 (Torres) with amendments for an installation timeline consistent with Ordinance No. 0-17172 (N.S.) and clarifying the criteria the Fire Department will use to exempt residential high-rise structures be and the same are hereby approved.
