WHEREAS, the provisions of Council Policy No. 600-15 require that a noticed public hearing be conducted before the City Council prior to the vacation of certain City streets; and

WHEREAS, the vacation of a street reservation within Bernardo Greens Unit 24, Map 7348, and adjacent to Lot 2564 of said map has been initiated by the submission of a tentative parcel map; and

WHEREAS, Section 66499.20½ of the California Government Code provides that the filing of a final subdivision map shall constitute abandonment of all streets and easements not shown on said map; and

WHEREAS, the proposed Tentative Parcel Map (TM-88-1064) contains a street reservation that is no longer required for street purposes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That THE STREET RESERVATION ADJACENT TO Lot 2564 of Bernardo Greens Unit 24, Map 7348, all within Tentative Parcel Map TM 88-1064 boundaries, as more particularly shown on the attached Exhibit "A," on file in the Office of the City Clerk as Document No. RR-2732077, which is by this reference incorporated herein and made a part hereof, be, and the same is hereby ordered, vacated, as provided under Section 66499.201 of the California Government Code.

- 2. That the Resolution shall not become effective unless and until the final parcel map TM 88-1064 has been approved and recorded. In the event that the final map is not approved within six (6) years of the adoption of this Resolution, this Resolution shall become void and be of no further force of effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this Resolution, with Exhibit "A," attested by him under seal, to be recorded in the Office of the County Recorder.


