ADOPTED ON APR 13 1989

WHEREAS, on March 15, 1989, the City Manager presented recommendations to the Committee on Rules, Legislation, and Intergovernmental Relations regarding The City of San Diego's long-term financing plan; and

WHEREAS, during deliberation of the City Manager's recommendations, the Committee on Rules, Legislation, and Intergovernmental Relations authorized the Mayor and City Manager to develop a committee of citizens to review the City Manager's long-term financing plan for public facilities; and

WHEREAS, said Citizens Infrastructure Committee will review standards for public facilities, cost of meeting standards, seek public participation, and advise the Mayor and City Council as to the most appropriate method for financing those facilities; and

WHEREAS, the Mayor and City Manager have identified various organizations whose participation would benefit the development of a Citizens Infrastructure Committee, said organizations to include City community groups, environmental groups, community based organizations, building industry, financial community, labor organizations, League of Women Voters, San Diegans Inc., San Diego Chamber of Commerce, San Diego Taxpayers Association, Senior Citizens' President's Council, Friends of the Library, Park and Recreation Board; and

WHEREAS, John Fowler has served The City of San Diego for twenty-seven years as one of our most capable and productive civil servants; NOW, THEREFORE,


