BE IT RESOLVED, by the Council of The City of San Diego that the low bid of AMERICAN PROCESSING CO., INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for COLLECTION & REMOVAL OF WET SCUM FROM SEDIMENTATION TANKS AT THE METRO WASTEWATER TREATMENT PLANT (Alt. A) as may be required for a period of one (1) year beginning May 1, 1989 through April 30, 1990 at a cost of \$41.50 per crew hour for labor and equipment, for a total estimated annual cost of \$121,000.00; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods, with a price escalation not to exceed 15% of prices in effect at the end of each year; and the option to change the pricing structure per Alternate B if the City requires enough hours of service (over 2,920 hours per year) to make Alt. B pricing more cost-effective.

BE IT FURTHER RESOLVED that in the event the contractor fails to perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate the contract and to reaward to the next low responsible and responsive bidder, and to subsequent low bidders, if necessary, until a bidder is found who does perform to specifications.
