ADOPTED ON APR 17 1989

BE IT RESOLVED, by the Council of The City of San Diego that MENZIES INTERNATIONAL is hereby declared in default of the contract for providing GUARD SERVICE AT THE MIRAMAR LANDFILL as may be required for a period of one (1) year beginning November 1, 1988 through October 31, 1989, which was authorized by Resolution No. 272029, adopted on October 10, 1988, and the company's guard service is hereby terminated.

BE IT FURTHER RESOLVED, that the balance of the contract is hereby awarded to the second low bidder, ADT-STERLING SECURITY SERVICE, at a cost of \$9.75 per worker hour; terms net; with options to renew contract for four (4) additional one (1) year periods, with price escalations not to exceed 3% of prices in effect at the end of each year.

BE IT FURTHER RESOLVED, that in the event the new contractor fails to perform in accordance with specifications, the Purchasing Agent is hereby authorized to terminate that contract and to reaward to the next low responsible and responsive bidder, and to successive low bidders, if necessary, until a bidder is found who does comply with specifications.

BE IT FURTHER RESOLVED, that in the event that no bidder who submitted a bid for this contract can comply with the specifications, the Purchasing Agent is hereby authorized to obtain this service on the open market until the contract can be rebid.
