

2. For the benefit of the contractor, subcontractor and to persons renting equipment or furnishing labor or materials, to the sums of \$30,451.00, \$87,873.25, \$305.50, \$47,138.50, \$37,368.50, \$47,874.25, \$10,582.25, and \$20,958.50, respectively.

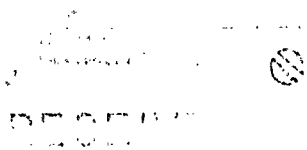
