
RESOLUTION NUMBER R- 273253

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a flat rate lease agreement with GIBBS FLYING SERVICE, INC., for a term commencing on the first day of the month following execution of this lease agreement by the City Manager and continuing until May 31, 1990, with an option to extend for three additional five-year periods, for the use of a 1.25-acre site immediately north of its existing lease area on Montgomery Field for commercial aviation purposes, at an initial minimum monthly rent of \$216, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 273253.
