BE IT FURTHER RESOLVED, that the City Council authorize the City Manager to execute additional agreements with RETC, as necessary, to accept additional funds from RETC to permit REGY to conduct the operational phase of the 1989 Summer Hire-A-Youth Program in the San Diego metropolitan area through September 30, 1989.
