WHEREAS, pursuant to San Diego Municipal Code sections 27.2615 and 27.2616, the Council must within ten (10) days reconsider the ordinance, and if the Council refuses to grant the petition to repeal said ordinance or fails to reconsider the ordinance within ten (10) days after presentation by the City Clerk, then the Council shall forthwith adopt a resolution of intention to submit the matter to the people at a special election or any other election at which all the voters of the City are entitled to vote, to be held within eleven (11) months

from the date the Referendary Petition is presented to the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the above referenced petition is hereby granted and the City Attorney is hereby directed to prepare and docket an ordinance repealing Ordinance No. O-17201 (New Series).
