

RESOLUTION NUMBER R-273259

ADOPTED ON APRIL 17, 1989

WHEREAS, the City Council had confirmed the cost of weed abatement against tax assessors parcel numbers 577-280-01 and 577-321-01 in the amount of \$4,469.00, which confirmation of costs was thereafter promulgated in Resolution No. R-272196 adopted on October 25, 1988 pursuant to the provisions of sections 54.0201 through 54.0206 of the San Diego Municipal Code; and

WHEREAS, it appears that the property owner had been notified that he would have to appeal such assessments to the City Council; and

WHEREAS, on October 25, 1988 the City Council hearing was conducted without the presence of the property owner and the costs of abatement were thereby confirmed; and

WHEREAS, further communications and review indicated confusion regarding the property owner's responsibilities to appear before the City Council in order to present his arguments; and

WHEREAS, it appears to be in the public interest to allow the property owner a further opportunity to appear before the City Council to eliminate any possibility of confusion and to ensure a full measure of due process; NOW, THEREFORE,



BE IT RESOLVED, by the Council of The City of San Diego, that City Council Resolution No. R-272196 adopted on October 25, 1988 be and the same is hereby rescinded insofar as it relates to the confirmation of costs against tax assessors parcel numbers 577-280-01 and 577-321-01 in the amount of \$4,469.00 for weed abatement.

BE IT FURTHER RESOLVED, that pursuant to the provisions of sections 54.0201 through 54.0206 of the San Diego Municipal Code, a public hearing to determine the confirmation of costs is hereby directed to be held on or before June 6, 1989, the property owner having been duly noticed, for the purposes of the confirmation of costs of weed abatement against tax assessors parcel numbers 577-280-01 and 577-321-01 in the total amount of \$4,469.00 to be apportioned against each parcel at the sum of \$2,234.50 per parcel.
