RESOLUTION NUMBER R- 273276 ADOPTED ON APR 18 1989

A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE CONSTRUCTION, OPERATION AND MAINTENANCE OF A PUBLIC STREET OR STREETS AND INCIDENTS THERETO, TOGETHER WITH EARTH EXCAVATIONS OR EMBANKMENTS, SLOPE OR SLOPES AND INCIDENTS THERETO AND A STORM DRAIN OR DRAINS AND INCIDENTS THERETO IN A PORTION OF PARCELS 1 AND 2 OF PARCEL MAP NO. 13432 FILED ON AUGUST 17, 1984, WITH THE SAN DIEGO COUNTY RECORDER, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITION OF EASEMENTS IN SAID PROPERTY FOR SAID PUBLIC STREET OR STREETS AND INCIDENTS THERETO, TOGETHER WITH EARTH EXCAVATIONS OR EMBANKMENTS, SLOPE OR SLOPES AND INCIDENTS THERETO AND A STORM DRAIN OR DRAINS AND INCIDENTS THERETO; AND THAT THE PROPOSED PROJECT IS PLANNED IN A MANNER THAT WILL BE MOST COMPATIBLE WITH THE GREATEST PUBLIC GOOD AND THE LEAST PRIVATE INJURY; AND DECLARING THAT AN OFFER TO PURCHASE THE PROPERTY. PURSUANT TO GOVERNMENT CODE SECTION 7267.5, AT THE APPRAISED FAIR MARKET VALUE HAS BEEN MADE TO THE OWNER OF RECORD OF THE PROPERTY AND REJECTED; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY AND EASEMENT UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY AND EASEMENTS AND ACQUIRING IMMEDIATE POSSESSION THEREOF.

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure and also has provided all persons a reasonable

opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; and

WHEREAS, the City of San Diego desires to acquire the property hereinafter described for the construction, operation, and maintenance of a public street or streets and incidents thereto together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto in a portion of Parcels 1 and 2 of Parcel Map No. 13432 filed on August 17, 1984 with the San Diego County Recorder, all in the City of San Diego, County of San Diego, State of California as more particularly described hereinafter; and

WHEREAS, the City of San Diego has the power of eminent domain pursuant to, inter alia, Sections 1240.010, 1240.110, 1240.120, 1240.420, 1240.610 and 1255.410 of the California Code of Civil Procedure; Section 220, The Charter of the City of San Diego; Sections 37350.5 and 40404 of the Government Code and Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code; and

WHEREAS, it is in the public interest and necessity to acquire the subject real property as hereinafter described for the purpose of the construction, operation and maintenance of a public street or streets and incidents thereto together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto;

NOW, THEREFORE, BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF SAN DIEGO, AS FOLLOWS:


Section 1. That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the construction, operation and maintenance of a public street or streets and incidents thereto, together with earth excavations or embankments, slope or slopes and incidents thereto, and a storm drain or drains and incidents thereto in that portion of Parcels 1 and 2 of Parcel Map No. 13432 filed on August 17, 1984 with the County Recorder, all in the City of San Diego, County of San Diego, State of California, as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of the City of San Diego, and the inhabitants of the City of San Diego, demand the acquisition and taking of easements in said property for the construction, operation and maintenance of a public street or streets and incidents thereto, together with earth excavations or embankments, slope or slopes and incidents thereto, and a storm drain or drains and incidents thereto; said real property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That Section 220, the Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.420, 1240.610 and 1255.410, Code of Civil Procedure; Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code; and Sections

37350.5 and 40404, Government Code, <u>inter alia</u>, permit the acquisitions referenced herein.

Section 4. That the parcels of real property and the interests sought to be condemned are described as follows:



LEGAL DESCRIPTION

All that portion of Parcel 1 and 2 of Parcel Map No. 13432 filed in the Office of the County Recorder of San Diego County on August 17, 1984, more particularly described as follows:

Parcel 3B - Slope Easement

A permanent easement and right-of-way for earth excavation or embankment, slope or slopes, through, over, upon, along and across all that real property described as follows:

Commencing at said Southwest corner of Parcel 1, Parcel Map 13432; thence along the Westerly line of said Parcel 1, North 14°31'34" West (record North 14°28'06" West), 98.25 feet to the TRUE POINT OF BEGINNING, being a point on the arc of a 951.00-foot radius curve concave Northwesterly, a radial to said point bears South 14°31'51" East; thence leaving said Westerly line and Northeasterly along the arc of said curve through a central angle of 13°11'00", a distance of 218.82 feet; thence tangent to said curve North 62°17'08" East, 317.37 feet; thence South 72°18'49" West, 72.67 feet; thence South 63°41'58" West, 100.08 feet; thence South 61°24'32" West, 131.63 feet; thence South 64°17'05" West, 111.03 feet; thence South 71°59'30" West, 106.94 feet; thence South 89°56'08" West, 12.61 feet to a point on said Westerly line of Parcel 1, Parcel Map 13432; thence along said Westerly line, South 14°31'34" East 16.23 feet returning to the TRUE POINT OF BEGINNING.

Section 5. That the taking and acquiring by said City of the real property and easements hereinabove described is deemed necessary for the construction, operation and maintenance of a public street or streets and incidents thereto, together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains and incidents thereto by the City of San Diego and the inhabitants thereof, for municipal purposes; that such use is a public use authorized by law (inter alia, Section 220, Charter of The City of San Diego; Sections 1240.010, 1240.110, 1240.120, 1240.420, 1240.610 and 1255.410, Code of Civil Procedure; Sections 37350.5 and 40404, Government Code and Sections 4090, 5101, 5102, 5023 and 5023.1 of the Streets and Highways Code); that for such public use, it is necessary that The City of San Diego condemn and acquire said real property.

Section 6. That said real property and easement is to be used for the construction, operation and maintenance of a public street or streets and incidents thereto, together with earth excavations or embankments, slope or slopes and incidents thereto and a storm drain or drains which are planned and located in a manner most compatible with the greatest public good and the least private injury.

Section 7. That an offer to acquire the property, pursuant to Government Code Section 7267.2, at the appraised fair market value has been made to the owners of record of the property.

Section 8. That the City Attorney of The City of San Diego be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of The City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the certain real property and existing improvements as hereinbefore described as easements, for the use of the City of San Diego to take immediate possession thereof.
