RESOLUTION NUMBER R- 273280

ADOPTED ON APR 18 1989

WHEREAS, on February 27, 1989, the Council of The City of San Diego adopted the Resource Protection Ordinance (RPO), Ordinance No. O-17253 (New Series), which provides for the protection of mapped and unmapped resources and environmentally sensitive resources within the City; and

WHEREAS, the provisions of RPO identify mapped boundaries of resources, including floodways, floodplains, wetlands, and hillside areas, which may require prehistoric, historic, and biological surveys for purposes of obtaining a Resource Protection Permit; and


WHEREAS, certain resources, including unmapped wetlands, significant prehistoric and historic sites and resources, and biologically sensitive lands, are not mapped; and

WHEREAS, in order to provide protection for these unmapped environmentally sensitive resources, section 101.0462.D.3 of RPO requires the Planning Department to prepare maps which identify properties that will not require prehistoric, historic, or biological surveys; and

WHEREAS, the purpose of these maps is to enable City staff to expeditiously and accurately make determinations for properties which may or may not require a Resource Protection Permit, without requiring unnecessary biological or archeological studies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that those certain maps entitled "RESOURCE PROTECTION ORDINANCE CLEAR AREA MAPS," on file in the Office of the City Clerk as Document No. RR- 273280, are hereby approved and adopted in order to facilitate the implementation of the Resource Protection Ordinance.
