Dolores Enama	City Treasurer	\$320.00	Ms. Enama is a Public Information Clerk. She suggested having a program to list all personalized license plates with outstanding parking cites. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Alfred Gagon	General Services Buildings Division	\$204.01	Mr. Gagon is a Refrigeration Mechanic with the Buildings Division. He suggested returning 95 T4000 605 conversion kits in exchange for coverplates and mounts. This has accomplished a one time savings of \$680.04. This is his full award.
Laura Jambrosic	City Clerks	\$160.00	Ms. Jambrosic is a Clerical Assistant II. She suggested adding a typed list of names (for distribution) for additional materials distributed. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Hortencia Galvez	Waste Management	\$160.00	Ms. Galvez is a Sanitation Driver II. She suggested sup- pling each trash truck, with two or more persons, a hand held stop sign to use in tight situations and heavily traveled streets. Although savings are difficult to identify, this was considered
