German Gonzalez	Personnel	\$100.00	Mr. Gonzalez is an Associate Personnel Analyst. He suggested changing the format of employment newspaper ads. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Eric Schmidt	Water Utilities	\$ 80.00	Mr. Schmidt is a Ranger/Diver I with the Water Production Division. He suggested seeding the bare dirt area inside the diving compound at Lake Murray, instead of buying soil. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Daryl Wehrhan	Water Utilities	\$ 65.00	Mr. Wehrhan is a Waste Water Plant Operator with the Metro Division. He suggested the installation of handrails on the Carbon Towers (over the Clairifiers) at the Odor Removal Towers. Although savings are difficult to identify, this was considered to be a significant operational improvement. This is the remainder of his award.
Barbara DeHelena	City Treasurer	\$ 50.00	Ms. DeHelena was a Senior Typist at the time of this suggestion. She suggested posting signs referencing CA Civil Code AB1226/Section 1719 - bad check liability. Although savings are difficult to identify, this was considered to be a significant operational improvement.
