BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000 from the Sewer Revenue Fund (No. 41506), Wastewater Engineering Program (No. 70820), is hereby authorized, solely and exclusively for the purpose of providing funds for the above study.
