
RESOLUTION NUMBER R- 273309

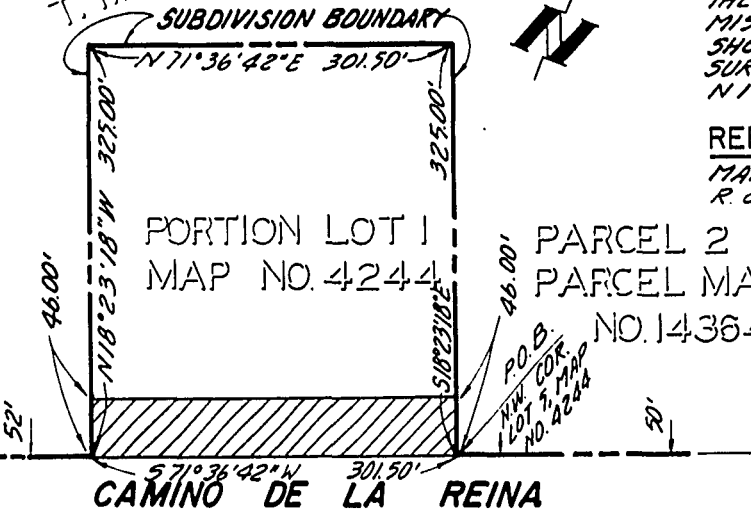

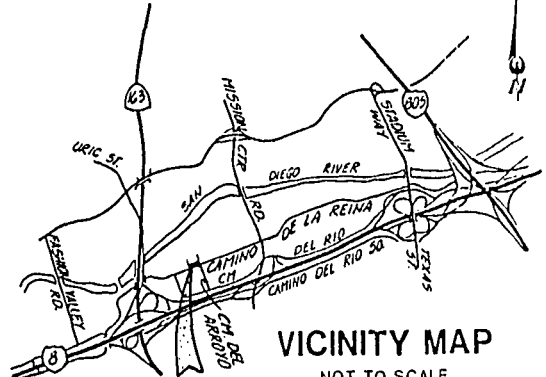
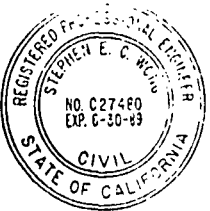
