RESOLUTION NUMBER R- 273312

ADOPTED ON MAY 1 1989

WHEREAS, every year more than 10,000 American workers are killed on the job; and

WHEREAS, many thousands more are permanently disabled and millions are injured; and

WHEREAS, another 100,000 workers die from cancer, lung disease and other diseases related to toxic chemical exposure at work; and


WHEREAS, California has one of the highest incidence of work related fatalities, a reported average of 740 deaths each year from 1980 to 1985; and

WHEREAS, April 28th, the anniversary date of the Occupational Safety and Health Act (OSHA), has been designated as the nation's first Workers' Memorial Day to remember the victims of work place injuries and disease; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does

hereby designate April 28th as Workers' Memorial Day in San Diego, in recognition of workers killed, injured and disabled on the job.
