BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low bid of \$60,985 by W. F. MAXWELL, INC., a corporation, meeting specifications for MISSION TRAILS PARK - FOOTBRIDGE IMPROVEMENTS, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119131.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$10,485 within Sewer Revenue Fund 41506, from the Unallocated Reserve 70697 to the Sewer Mains and Manhole Maintenance Program 70440.

3. That the expenditure, not to exceed \$10,485 from Sewer Revenue Fund 41506, Sewer Mains and Manhole Maintenance Program 70440, to supplement funds previously authorized by Resolution No. 272852, adopted on February 13, 1989, is hereby authorized solely and exclusively for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
